## Annual Meeting (Zoom) Monday, Sept. 20, 2021 6:30 pm Registration 5:30 pm

The continued pandemic has forced us to take care of business in new and different ways, and for the first time ever, this year's Annual Meeting for Honolulu Park Place will be held via Zoom.

Because the City's guidelines allow no more than 25 people in an indoor meeting, and because Harris United Methodist Church, where annual meetings have been held in the past, is not available, a Zoom link will be provided prior to the meeting.

This will require that you log-in with your computer, smartphone or tablet to "attend" the meeting. There will not be an owners' forum; if you want to speak, you will need to come downstairs to the lobby. Voting will be done during a recess by bringing your ballot in person to a designated location on the lobby floor.

Whether or not you plan to attend the meeting, it is important that you sign the proxy and return it to Hawaiiana Management in the self-addressed, stamped envelope. You can also deliver the proxy to the HPP Admin office, or sign your proxy at the table in the lobby.

This will insure a quorum so that business may be transacted.

#### Why should I care about this?

Annual meetings usually address topics that may sound dry as dust to you, as a homeowner. These might include the association's budget, election of directors, and voting on amendments to the HOA's governing documents. The meetings can also

# **Security Desk News**

By now, residents have noticed that the old security desk is gone. In addition to being too small, the old desk's basic structure had deteriorated such that we could no longer delay replacing it. The new desk is taking shape and is expected to be completed in the next few weeks. When completed, it will have space for a second officer to prepare reports. The small room behind the desk, where reports have been prepared, will be devoted entirely to security equipment hardware and bins for lost and found items.

The new desk will also provide at least three times as much space for monitors for the building's cameras. This will allow for the expansion of the security system as needed. When completed, the new desk will feature a darker shade of quartz material on the desktop and the eight inset panels on the exterior facade. It will also have tinted glass on the Beretania side of the desk that will help to shield the officers from the afternoon sun.

The members of the security desk committee worked closely with General Manager **Walters Miranda** to establish the minimum requirements for the new desk. The committee also found an architect with 50 years of experience to come up with plans to bring ideas to reality. Even in its unfinished state, the new desk is a definite step forward for security, the entrance lobby and for the building.
