#### We Love Our Pets ... BUT!

You are reminded that all pets and assistance animals must be registered with the HPP Office. But more importantly, pet dog owners, whether they are an owner or renter of a unit, **shall carry liability insurance with stated limits of not less than \$500,000.00 per claim** for bodily and/ or personal injury naming "Association of Apartment Owners of Honolulu Park Place" as an "additional insured" on such policy. **All pet dog owners must provide the Administrative Office a current Certificate of Insurance evidencing this coverage at the time of pet registration**.

Recently there was an incident at HPP which resulted in a visitor being bitten by a dog. Owners are reminded that they are responsible and liable for any injury or damage caused by the animal.
